Terms & Shipping Fees (GST or HST applies to Canadians)

What We Need From You:

- The Breeding Contract & stud fee **must be received by the stallion owners prior to the semen being shipped**. Payment of all shipping costs are the responsibility of the mare owner and will be billed to credit card or courier account.
- Please **SEND A COPY OF YOUR MARE'S REGISTRATION PAPERS** with the contract.
- The stud fee includes 3 collections per year. After 3 collections, a fee of \$100.00 per collection will be charged to your credit card.

Shipping Costs & Payment Methods:

- **Disposable Semen Shipping Box (\$40.00):** Each shipment will be shipped in a disposable shipping box. The cost of the box can be paid in the same manner as the stud fee; E-Transfer, PayPal invoice or check. **DO NOT RETURN SHIPPING BOX.**
- **Purolator Courier: (Canada only)** Charged **directly** to your Credit Card or Purolator account. We can ship for next day delivery to be received Tuesday to Saturday in most locations. Purolator doesn't ship on Saturday or Sunday for next day delivery.
- **Semen Transport to FedEx - (\$75 to \$100):** Payable by E-Transfer, PayPal invoice or check.
- **FedEx Courier: (For U.S. Clients)** Charged **directly** to your Credit Card or FedEx account. We can ship for next day delivery to be received Tuesday to Saturday in most locations. FedEx doesn't ship on Saturday or Sunday for next day delivery.

Conditions

- 1) Have your vet call us on the **first day of your mare's heat cycle** so that we may plan the breeding.
- 2] **WE MUST BE CONTACTED BY TELEPHONE THE DAY BEFORE THE SEMEN IS TO BE SHIPPED.**
- 2) **Semen Transportation:**
 - We will ship the semen on the designated day via prearranged transport and notify you or your veterinarian with the details of the shipment and arrival time.
 - The Stallion Owners assume responsibility to ship semen that will be live and viable at the time of arrival at the Mare Owner's farm or other designated location.
 - Should the semen not arrive in a viable condition at the time of delivery, the Stallion Owners will bear the cost of transportation for the next shipment unless the semen is lost or delayed due to the negligence/difficulties of the courier, in which case we will try to get a refund from the courier.
- 3) **A BREEDING CERTIFICATE is included with the shipment of semen** to be filled out & signed by the veterinarian or A.I. Technician. **PLEASE KEEP THIS BREEDING CERTIFICATE AS IT IS NEEDED TO REGISTER THE FOAL.** Please **fax, mail, or email us a copy** of the Breeding Certificate after the mare has been ultrasounded for pregnancy (**by August 31st**) as we need this information to complete our Stallion Report.
- 4) All unused semen must be destroyed and under no circumstances may any other mare, other than the designated mare in this contract, be inseminated.
- 5) Should the mare die or become unfit for breeding, then a different mare approved by the Stallion Owners may be substituted.
- 6) If the Stallion should die, or otherwise become unfit for service **before any semen is shipped** then this agreement shall automatically terminate and Crooked Creek Farm shall refund to the Mare Owner all fees paid.
- 7) The Mare owner shall assume all responsibility for the condition of the mare and bear all risk of loss or injury to the mare, whether by death, disease, accident, injury, infection, or any other cause, and therefore agrees that the

Stallion Owners or any person employed or associated with them shall not be held responsible for any or all damages associated herewith. Any veterinary costs related to the said mare are the Mare Owners responsibility.

8) This Stallion Breeding Contract is not transferable by the Mare Owner to another party without the prior express written approval of the Stallion Owners. No substitutions for the mare may be made without prior approval by the Stallion Owners.

9) **Live Foal Guarantee**

The Live Foal Guarantee is based upon full and complete adherence to the conditions listed below:

- A live foal is one that stands and nurses.
- Should the said mare fail to produce a live foal due to death of the foal, abortion, or failure to conceive (as determined by a veterinarian pregnancy check by August 31st), the Stallion Owners require a written statement from the Mare Owner's veterinarian with one week of occurrence.
- Upon failure to produce a live foal, the Mare Owner is entitled to a rebreed the year following the initial breeding. The Mare Owner then agrees to pay the booking fee (+ GST or HST Canadians only) which includes 3 collections.
- If the mare should fail to produce a live foal and the stallion dies or becomes unfit for service, then a substitute stallion will be offered or the full Stallion Stud Fee will be refunded to the Mare Owner. If semen has been shipped, the booking fee will be kept by the Stallion Owners for semen collection expenses.
- If the Stallion should die, or otherwise become unfit for service & the Mare Owner is entitled to a rebreeding under the provisions of the live foal guarantee, then Crooked Creek Farm will refund the Stallion Stud Fee less the booking fee for semen collection expenses.
- All outstanding breeding and shipping costs from the previous year must be paid in full or this contract will become null and void.

10) **Embryo Transfer:**

If you are considering Embryo Transfer Please contact us for our Embryo Transfer Conditions.

11) This breeding contract is valid for the current breeding year, stated on page 1, and the following year. If the contract has not been used during this time period, it will become null & void. You must contact Crooked Creek Farm for the dates of the "Breeding Season", as they may vary.

Information For Veterinarian or Breeding Farm

(Please make sure this goes with the mare to the Veterinarian or Breeding Farm)

- Our contact information is above.
 - Please call us on the **first day of the mare's heat cycle** so that we may plan the breeding.
 - To Order Fresh Cooled semen, **WE MUST BE CONTACTED BY TELEPHONE THE DAY BEFORE THE SEMEN IS TO BE SHIPPED**
 - **If for some reason you cannot let us know the day before, we need to know by 8:00 am CST the same day you need semen shipped.**
 - **Please leave a message with a telephone number as messages are checked frequently.**
 - We will notify you by phone with the details of the shipment & weigh bill number.
 - The semen will be shipped fresh chilled in a disposable shipping container.
- DO NOT RETURN SHIPPING BOX.**

A BREEDING CERTIFICATE is included with the shipment of semen to be filled out and signed by the veterinarian or A.I. Technician.

PLEASE MAKE SURE THAT THE MARE OWNER GETS THIS CERTIFICATE AS IT IS NEEDED TO REGISTER THE FOAL.

2018 Canadian Holidays During Breeding Season

Semen cannot be shipped or received by FedEx or Purolator on these days

Friday, March 30th – Good Friday

Monday, May 21st – Victoria Day

Monday, August 6th - Civic Holiday

Monday, April 2nd – Easter Monday

Saturday, July 2nd - Canada Day

Monday, September 3rd - Labour Day
